Director's Report

Director's written report

ED Willson shared the following items:

- The County may extend the due date for bids for the construction of the new Twin Beaches branch due to the large number of written questions regarding the bid documents.
- Or. Polsky recommends that Calvert Library discontinue the practice of sending out a press release for every COVID-19 case among library staff as long as contact tracing is not necessary. Library staff and customers will continue to follow the BOLT mask requirement and other safety protocols. Calvert Library is using MD Department of Health guidelines for return to work protocols.
- The preliminary report for Board Effectiveness survey has come out. ED Willson will
 forward electronically. Stay tuned for recommended training and next steps. We will
 discuss the preliminary report at the February BOLT meeting.
- Unique Patron Services phone and chat service began on Wednesday, January 19 and is going well. Their agents are friendly and helpful. A number of staff are reviewing transcripts from all calls and chat interactions to ensure quality.
- o Budget expenditures are normal.
- o Job offer has been made for SEED grant position, but it has not yet been formally accepted.
- o Anti-racism audit kicks off later this week, Mr. At Lee and Mr. Parran will represent the BOLT.
